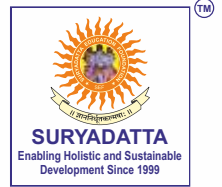

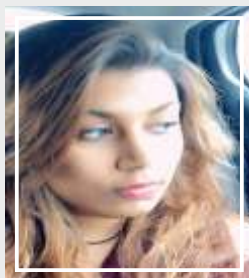


1 Dr Renu Raj
